REGULAR MEETING  
AUGUST 31, 2020**

The Oneonta City Board of Education met in regular session August 31, 2020, at 5:30 p.m. in the Oneonta High School Library. Members present were Don Maples, President, Patrick Adams, Ricky Hicks. Steve Anderton and Sharon Breaseale.

**AGENDA APPROVED:**

On a move from Mr. Anderton and a second from Mr. Adams, the board unanimously approved the agenda.
